**Section 4: First-Aid Measures Description**

<b>Inhalation:</b>	Follow standard care for a respiratory emergency as necessary. Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention immediately.
